**Description of Services**

Online proofing of images will be posted to the Photographer's website within 2 weeks of the session.

**Retainer and Payment**

Client shall make a \$250 non-refundable (except as hereinafter provided) retainer payment to secure services with the Photographer. Included in this fee is a \$100 print credit. PA Sales tax (6%) will be collected upon invoicing where applicable.

**Cancellation**

In the event of cancellation of this Agreement, the retainer will not be refunded. If cancellation occurs with less than 6 months notice, the Client shall forfeit all monies paid as full and complete liquidated damages, not as penalty. The Photographer requires written notification, signed by the Client prior to the session date.

**Limitation of Services**

The photographic services described herein shall be limited to no more than 1 hours of coverage. Additional time will be billed at \$75 per hour (plus applicable sales tax), if requested.

**Exclusivity**

Photographer is hereby retained as the sole and exclusive professional photographer to perform the photographic services contained herein. Client shall take any necessary action to ensure that Photographer and staff are not hindered while performing services

**Client's Obligations**

Client shall cooperate with the Photographer in the following ways: 1. identifying principal persons to be photographed, 2. advising Photographer, in advance, of the logical group poses, and 3. indicate the areas of coverage the Photographer might miss.

**Liability of Photographer**

In the event this Agreement cannot be completed due to unforeseen circumstances (war, illness, accidents, acts of God, etc.) beyond the control of the Photographer, Photographer's liability to the Client shall be limited to the return of the Client's retainer. Photographer's maximum liability shall be limited to the return of the Client's payment. In the event that the Photographer becomes ill, injured, or for any other reason cannot fulfill this contract, the Photographer will find a suitable replacement or return the Client's total payment.

The high resolution files that are included with coverage grants the Client the right to make unlimited reproductions for personal use only. Julie Bee Photography, Julie Lewis, retains the copyright to these images, and the Client agrees not to offer these images (or the use of these images) for resale or commercial use.

2. The Client hereby grants the Photographer the irrevocable and unrestricted right to use and publish photographs of the Client or in which the client may be included, for editorial, trade, advertising and any other purpose and in any manner or medium; to alter the same without restriction; and to copyright the same.

3. Every effort will be made to furnish only the highest quality portraiture. The quality of your photographs will reflect the weather and the Client's ability to cooperate with the Photographer. The Photographer is not responsible for the lack of coverage due to the weather, client schedule complications, or the rules/restrictions of the location. There is no guarantee that a specified photograph or a specific pose will be take.

Any additional retouching is subject to a fee.

5. Current pricing will apply to all orders. Payment on re-prints and/or enlargements is due when the order is placed. Minimum print order is \$100.

6. This Agreement incorporates the entire understanding of the Client. Any modifications of this Agreement must be in writing and signed by all parties. Each Client signing shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement. The Client has read this Agreement and agrees to all of its terms and acknowledges receipt. This Agreement is governed by the laws of the state of Pennsylvania.
